## **Tournament Rules**

- Tournament is in a team format with maximum two (2) anglers per boat. A one (1) person team is acceptable. If a participant is under the age of 18, he must be accompanied by a team member 18 years or older who will assume responsibility in all matters.
- No alcohol allowed.
- Each team must check in at the tournament site prior to the tournament for boat check. Each team member must completely fill out and sign the registration form.
- Take-off positions will be given out the day of the tournament. Blast-off position is determined when the entry fee is received, either by mail or at the ramp on the morning of the tournament.
- Tournament hours will be from safe light to 3:00 p.m. unless otherwise stated prior to the tournament start.
- A penalty of three (3) pounds will be assessed for each short fish brought to the scales. In addition, that fish will not be weighed, and that team will be disqualified from the Big Bass Competition.
- Any team bringing more than one short fish to the scales will be disqualified from competition for that day.
- The limit shall be five (5) bass per boat. All bass must be a minimum twelve (12) inches in length, measured on a "Golden Rule" flat board with the mouth closed, and moving the tail side-to-side.
- A four (4) ounce (.25 pound) penalty will be assessed for each dead fish brought to the scales. The four (4) ounce dead fish rule will also apply to the Big Bass competition. In accordance with the Georgia Law, DEAD FISH MAY NOT BE CULLED. Any culling at the weigh-in site will result in disqualification. All live fish will be released at the weigh-in site.
- Teams that are not in the official weigh-in area at the appointed times will be penalized one (1) pound starting with their big fish, for each minute they are late. Any team more than five (5) minutes late will be disqualified.
- All State Game and Fish laws will be observed.
- All competitors are expected to show courtesy to other competitors alike.
- Fishing on tournament waters is permitted, except within fifty (50) yards of a marina, gas dock, or another competitor's boat which is anchored and the trolling motor is up.
- Contestants are not allowed to leave the boat, except in case of emergency.
- Protests may be registered at two (2) times during a tournament: after the early morning briefing and before blast-off; and after the weigh-in and before the awards presentations. All protests must be registered personally with the tournament director and must be accompanied by \$100.00 cash. The Ingleside Baptist Church tournament committee will rule on all protests, and their decision is final.
- Only artificial lures may be used; NO live bait. TROLLING IS NOT ALLOWED. All bass must be caught live and in a conventional manner with a rod and reel.
- There shall be one official checkpoint for boat-check in the morning and check-in in the afternoon. Failure to go through boat-checks will result in disqualification.
- Safety equipment adequate to pass Coast Guard regulations must be in the boat at all times. Life jackets are required to be worn when operating the gasoline engine.
- There will be NO official practice period and NO off-limits period prior to the event.
- All entries must have liability insurance on their boat and occupants.
- Any participant that has been previously disqualified for cheating in another fishing tournament cannot participate in this tournament.
- Interpretation of these rules shall be left exclusively to the Ingleside Baptist Church tournament officials. The decision of the tournament director shall be final in all matters. Infraction of these rules may be grounds for disqualification for this and future events. Tournament officials reserve the right to refuse any applicant without cause. Tournament director's decisions will be accepted by participants without further appeal. Entry fees will not be refunded for disqualifications.
- The Ingleside Baptist Church tournament committee may elect to conduct polygraph exams. All participants subject to a polygraph exam must successfully pass the exam to collect any prize money.
